No person shall be nominated as a candidate for election unless he/she signifies his/her consent on the nomination form. A voter or Candidate shall not propose or second the candidature of more persons than the total number of representatives to be elected in that group.
- The age limit and other eligibility conditions to contest elections shall be as given in the Rule 04 for conduct of College Students' Council elections.
- The students of Part II, S.Y, T.Y (or higher classes) and Ph. D should submit their College Identity Card. The students of Part-I and the First Year (F.Y.U.G) should submit their fee receipt in case the Identity Card is not issued.
- 5. The candidates who are contesting the election should be present 15 minutes before the commencement at the venue of voting on the day of the election. If no candidate is present at the time of starting of election, the Election Officers present will seal the ballot box in their absence and no complaint shall be entertained thereafter.

6. A nomination form which does not comply with all the above-mentioned requirements shall be
