| <b>Report</b>                                         | <p><b>Objectives:</b> To encourage women to join the Reserve Bank of India at a managerial level and attain financial independence.</p> <p><b>Brief description:</b> The talk began with a brief on the Reserve Bank of India, India's central bank by Ms Deepika Negi; she told the participants that while the public cannot open accounts in RBI, it acts as the monetary authority, currency issuer, regulator and supervisor of the financial system, banker to governments and banks, and manager of foreign exchange and payment systems. RBI manages currency by deciding how much money to print and distribute through four printing presses, replaces spoiled notes via banks, and prints currency in consultation with the Government of India. Working with RBI offers women prestige, job security, work-life balance, continuous learning through training colleges and online courses, and opportunities across RBI offices located in state capitals. She highlighted the benefits of work at RBI, including Equal opportunities, a rewarding career, supportive HR climate, attractive compensation and the advantage of acquiring expertise in the field.</p> <p>When joining a bank/RBI, candidates clear preliminary and main exams; and managers can earn ₹1–2 lakh per month over time, with roles guided by national policy and opportunities open to students from all streams, including internships (applications usually in March via RBI website).</p> <p>RBI offers a supportive, women-centric work culture with flexi hours,</p> |
